THE CORPORATION OF THE TOWNSHIP OF MADAWASKA VALLEY

BY-LAW NUMBER 2019-25

Being a By-law to establish a Terms of Reference for the Station Keepers of the Barry's Bay Railway Station and to establish a Memorandum of Understanding between the Township of Madawaska Valley and the Station Keepers with respect to the facility use of the Barry's Bay Railway Station.

WHEREAS by virtue of Section 10 (2) of *The Municipal Act*, 2001, S.O. 2001, c.25, as amended, a municipal council may pass by-laws relating to services and things that the municipality is authorized to provide.

AND WHEREAS the Council of the Corporation of The Township of Madawaska Valley deemed it advisable to establish a Terms of Reference for the Station Keepers for the Barry's Bay Railway Station and establish a Memorandum of Understanding for the facility use for the Barry's Bay Railway Station;

NOW THEREFORE the Council of the Corporation of the Township of Madawaska Valley enacts as follows:

- 1. THAT the Station Keepers is a newly formed community volunteer group with a mandate to promote the Railway Museum, the heritage and culture of the Madawaska Valley.
- 2. THAT the group has expressed interest in occupying the Barry's Bay Railway Station.
- THAT the group is seeking assistance through lobbying other fundraising groups to partner
 with this initiative to assist with fundraising to establish self-sustainability with cost sharing
 for operating costs by 2021.
- 4. THAT the Township of Madawaska Valley recognizes the Station Keepers as a community volunteer group and hereby establishes a Memorandum of Understanding with the Station Keepers for the facility use at the Barry's Bay Railway Station reporting solely through the CAO/Clerk until which time they are established as or affiliated with a federally incorporated non profit organization.
- 5. THAT the Council of The Corporation of the Township of Madawaska Valley, hereby establish a Terms of Reference for the Station Keepers for the Barry's Bay Railway Station and a Memorandum of Understanding for facility use of the Barry's Bay Railway Station as outlined in Schedule "A" attached hereto.
- 6. THAT this By-Law shall take effect upon the date of enactment.

TERMS OF REFERENCE

for the

Station Keepers of the Barry's Bay Railway Station

Purpose:

The Station Keepers of the Barry's Bay Railway Station, as a Community Volunteer Group, will provide museum and gallery services, promotion awareness, and enhancement of the culture and heritage for the Madawaska Valley Township and throughout the Township of Madawaska Valley

Under the auspices of Recreation, Heritage and Culture the Station Keepers of the Barry's Bay Railway Station will address and provide input into matters in particular:

To establish general parameters for responsibility in maintaining the museum and gallery as a public space

Membership:

The Station Keepers of the Barry's Bay Railway Station shall consist of a group of dedicated volunteers with interest and knowledge of culture and heritage and programming to generate interest and information. The membership is undertaking steps to develop partnerships and affiliations with other local groups that may assist in volunteering, promotion, fundraising and programming to preserve and promote the heritage and culture of the Madawaska Valley.

Meetings:

Station Keepers of the Barry's Bay Railway Station would meet at the Railway Station and use this location as the place where they establish their operational centre (ie, website, phone, messages)

Department Jurisdiction:

The Station Keepers of the Barry's Bay Railway Station may have multiple partnerships or affiliations working under them; the Station Keepers will report directly to the CAO/Clerk through the manager of the Station Keeper. The Recreation Community Development Coordinator will be the contact for municipal services/repairs/events coordination assistance that the manager would contact when needed. Members of the Station Keeper may attend any Recreation, Heritage and Culture meeting throughout the year to bring updates if they so choose. Minutes, events and requests would be forwarded to Council through the Station Keepers Manager through the CAO/Clerk for inclusion in the Regular Council Meeting Package.

Staff Contact

The main staff contact will be the CAO/Clerk or designate for the Township. The Manager for the Station Keepers of the Barry's Bay Railway Station would be their manager. Requests or work as it pertains to the recreational facility would be done through the manager to the Recreation Community Development Coordinator or designate to direct the request or concern to the appropriate department.

The Municipality is responsible for the hire and oversight of students for the Railway Station for the Visitor Information Centre for the period of July to September. The students are directed by the Recreation Community Development Coordinator. Their duties include oversight for the Visitor Information Centre, and assistance with the artisan festival, Canada day events, the Taste of the Valley, and any other duties as directed by the Recreation Community Development Coordinator.
